### Membership Qualification:

Current membership of a recognised MacArthur Society as listed at [www.clanarthur.org](http://www.clanarthur.org) is a pre-requisite for membership of the Clan Arthur Ancestral Lands Trust.

### Membership Year:

The membership year commences on 5<sup>th</sup> April of each year and ends on 4<sup>th</sup> April of each year. Members joining in the last quarter of the year (after 1<sup>st</sup> January) shall be entitled to the next year's membership at no further cost.

### Membership Fees:

Membership fees are set by the Trustees and are reviewed at the AGM. Fees are currently set at £20.00 per annum. The Trustees reserve the right to grant honorary membership to Clan Arthur Ancestral Lands Trust donors.

### Membership Benefits:
